



Existing 50mph speed limit on southbound carriageway of A12 extended southwards (a 50mph speed limit already applies to the circulatory area of the roundabout)

- Proposed 50mph to tie into existing:
- 50mph speed limit on A12 (northbound)
 - 30mph speed limit on Anson Road (to east)
 - 30mph speed limit on Eagle Way (to west)

- Proposed 50mph to tie into existing:
- 30mph speed limit on Barrack Square (to east)
 - 30mph speed limit on Eagle Way (to west)

Proposed 50mph speed limit for approximately 496m

Proposed extension of existing 30mph speed limit for 70m

Proposed 50mph speed limit from existing 30mph in Ipswich to the A12 (3.26km)

Proposed 40mph speed limit from the A12 to a point 60m east of the centre of the Newbourne Road junction (approx. 2.49km)

Proposed 50mph speed limit on northbound carriageway, starting 487m south of the centre of the Foxhall Road/Walsdringfield Road roundabout

Proposed 50mph speed limit on southbound carriageway to terminate at a point 83 metres south of its roundabout junction with Foxhall Road and Walsdringfield Road

A12 to remain subject to National Speed Limit south of proposed 50mph speed limits
